- 6. **Hurricane Preparedness** Gary will organize putting up shutters and storing pool furniture in the case of a hurricane. Mike noted that the hurricane shutter bar on the bottom of the French doors leading out to the pool is missing. The Board will check the garage closet to see if the bar is in there and will also set up a time to clean it out.
- 7. **Bylaws Committee** Gary will continue to manage this project. Currently the email with proposed changes has been sent to the community asking for questions to be submitted by 10/31. The next step will be to hold a vote on this first set of changes.
- 8. Capital Improvements Reserve Merritt will work with Bob Cooil on updates needed.

Other items:

- 1. A community wide Volunteer Day will be scheduled in March.
- 2. Clubhouse Leak Mike and Bob are trying to find a valve detector to find the leak.
