CALL TO ORDER

Mike Smith called the meeting to order at 10:15am

New Construction:

509 Settlers – Pool and storage shed installed; landscaping is still ongoing. Mike will check on their deposit.

- 2. **Lawn Monitoring** Debbie reported that some weeds are growing high. Kim sent an email to the community. Debbie will follow up with pictures to the office in mid-April if anyone needs to be contacted.
- 3. **Pools** The cabana pool will be resurfaced tomorrow. Mike will order 13 umbrella bases from Amazon. The leak in the clubhouse pool is repaired. The ladder will be installed soon. The pool table company is sending a new top free of charge for the one that was damaged.
- 4. **By-Laws/Covenants review** Kim will send the list of all who haven't voted to the board. Gary will break up the list and ask the board member to call everyone. Gary made a motion to extend the vote by 30 days.
